This letter is to remind you that your helper's work permit will expire on 08 Jun 2017.

There are a few things you need to do if you want to keep her. We have included another handy checklist over the page in case you mislaid the original. Use it to make sure you have everything ready before you renew.

If you don't intend to renew your helper's permit, you will need to think about transferring her to another employer or sending her home. It takes around two weeks to make a transfer, so do look into this now if this is what you plan.
