## Your underage FDW cannot work in Singapore

Dear POON WENG YUEN

We found your foreign domestic worker (FDW) **NO NGAIH MAN WAI** to be below the minimum required age of 23. We have taken back her work pass. She must return to her home country and she can no longer work in Singapore.

We know this may be disruptive to you. Unfortunately, you will have to look for another FDW. Your Employment Agent (EA), UNITED CHANNEL EMPLOYMENT AGENCY PTE. LT has been notified of this too.

We are also checking on UNITED CHANNEL EMPLOYMENT AGENCY PTE. LT to see if they knew that the FDW was underage. We will be most grateful if you can share with us any relevant information that could help in our findings.
