Appeal for Waiver of Levy for April 2017 concerning FDW

There is a Myanmar maid hired by my mother to take care of her as she is 90 years of age and feeble.

I just received Bill for May 2017 levy and concern that there is no levy concession (\$60) for my mother's maid. The bill indicated that my mother has to pay the sum of \$367 which is extraordinary high. I have no choice but to make payment on behalf of my mother, otherwise the maid's work permit will be revoked. I am also concern that Levy for May 2017 is pegged at \$270.94 which will be deducted via GIRO on 19.6.2017.

I shall be very grateful if you could look into this matter and make the proper adjustment and refund the excess FWL payment.
