**Withdrawal of Approval to bring Foreign Domestic Worker (FDW) into Singapore  
NAN SOE (WP No. 0 94576431)**

We refer to the Letter of Notification to bring Foreign Domestic Worker (FDW) into Singapore. We have withdrawn the approval with immediate effect.

2 The approval has been withdrawn because the above-named foreign domestic worker (FDW) has failed to meet the MOM-stipulated requirements stated in the **Letter of Notification to Bring Foreign Domestic Worker (FDW) into Singapore.**

3 Your agency is required to repatriate the FDW to her town or place of origin within her home country **within 7 days, i.e. by 08/04/2019**, and bear the cost of her repatriation. You can use WP Online and go to "Special Pass Request" on the menu for the arrangement. Failure to do so is a breach of the EA License Conditions 11(a) and 11(b), and the Ministry will not hesitate to act against such behaviour.
