

In Feb/March 2019, I started suspecting that my domestic helper had been taking coins from my 5 year old son's piggy bank as she had not asked me to top up her prepaid card for a couple of months. I started making markings on the coins in the piggy bank and did not alarm her. On the above mentioned date, time and location, I made a check in my helper's belongings and discovered the coins with the markings in her possession. The total amount adds up to about SGD10/-, consisting of coins of different value. I have also found 2 pieces of 1 Ringgit in her possession, I would like to state that she does not have off days and does not leave the
